Do you remember when the Des Moines Chapter was recognized by National AGA for membership growth? The following was in the August 1982 Special Edition of AGA News.



Des Moines Chapter Places 1st in Class in Mid-western Region and 3rd in Class Nationally.

The Des Moines Chapter has beaten all competitors in winning the AGA Membership Goal Attainment Award in Group D of the Midwestern Region and placed 3rd nationally. The Chapter reached 107.55% of its membership goal and will receive an award of \$25.

Our Membership Chairperson, Joan Maust, will receive a special citation for her outstanding efforts this past year in the membership drive. Due to the growth in the Chapter membership, we will be moving to Class C in the Midwestern Region. The chapter had 78 members as of January 1992 that year.

I'm not sure how many size categories there were in 1992, but I don't remember any year with over 100 members. Currently, there are five membership categories. Group A is 300 or more members, Group B 150-299 members; Group C 100-149 members; Group D 50-99 members and Group E 21-49 members. The Des Moines Chapter is currently in Group D.



Update from the National Council of Chapters Representative, Kim Knight

2019-2020 is starting off with some exciting changes as a result of the change in the governance structure of AGA. I attended the first ever meeting of the National Council of Chapters (NCC) in New Orleans, Louisiana on Sunday, July 21. This was an interactive 3.5 hour meeting which was kicked off by National President-Elect, Wendy Morton-Huddleston. Wendy is from the Washington D.C. Chapter and will serve as AGA’s National President in 2020-2021.

The theme of the meeting was “an engaged member is a retained member.” I had the opportunity to speak on a panel with two other NCC Representatives about how we attract and retain members in our respective chapters. The Des Moines Chapter had a downturn in membership a couple of years ago as a result of long-time members retiring. Yet we are maintaining a strong Chapter membership and the participation in our events is outstanding. One of the key items I shared was that our membership was 71 in July 2017; it dipped to 64 in January 2018 and has recovered to 69 as of July 2019 (7.8% increase). This reflects the retirements I mentioned and then the growth from new members joining. Participation in our training events has been outstanding with over 100 attending our spring conference in April.

Our membership is 74% state employees and 13% retirees. We are striving to increase participation in other areas, including city and county government, federal government and private industry. We offer inexpensive CPE on a monthly basis and our meetings are a great opportunity to network and meet others who work in the field of government accountability.


October - Breast Cancer Awareness Month

Historian's Corner, Janice Evans:

Do you remember when there was no Internet. The following contains information from an article in the February 1996 AGA Ledger written by Shirley Hebrank, former Des Moines Chapter member and president (96-97).



Sources for Shirley's article were from training "Navigating the Internet" presented by Thomas P. Haberman, CISA, CIA from Deloitte Touche at an AGA Leadership workshop in Osage Beach Missouri, and an MBA class titled "Electronic Commerce". Links are to additional information found in Wikipedia.

- Statistics from 1996 (more recent):
 - o 30 million users of the Internet (there were 4.5 billion in mid-2019, or 58.8% of the world's population. It is estimated that almost 89% of the 329 Million people in the United States currently use the internet.)
 - o 50 million email users and growing by one million users a month. (Now over 3.9 billion.)
 - o Less than 1% of direct sales are made via the internet in the United States. (This had grown to 9 percent in 2017 and was expected to reach 12.4 percent in 2020.)
- Current Uses in 1996 included email communication with another user (easier than phone tag and faster than snail mail).
- Biggest Hurdle is Security - Digit cash or E-cash (tokens like ATM) can be used which does not leave any records and therefore cash can be sent internationally.
- Access through On-Line Services - Providers included [American On-line](#), [CompuServe](#), [Prodigy](#), [Netscape](#), etc. Software packages available included [Internet in a Box](#) and Net Cruiser by [Netcom](#), which was \$30 initially, then \$20 per month for 440 on-line hours monthly.
- Future uses included video conferences, business-to-business sales, retail sales, secure Transactions, and telecommuting
- Browsing Applications available included [Gopher](#) (Originated from the University of Minnesota); [TELNET](#) (used to access a remote computer); [World Wide Web](#) (A hypertext system linking information distributed across multiple servers around the world). For the World Wide Web these included [Yahoo](#), [Webcrawler](#), [Lycos](#), etc.
- Other Services included [WHOIS](#) (gives the user the ability to locate friends in other regions); [Wide Area Information Server \(WAIS\)](#) (Search and retrieve information from remote databases); TALK (live talk sessions with other users); [Internet Relay Chat \(IRC\)](#) (multi-user communications on specific topics); [CU-SeeMe](#) (Internet teleconferencing); and [\(Multimedia Backbone \(MBONE\)](#) (for multicast teleconferences).

The National Council of Chapters (NCC) met on February 4, 2020. There were a number of topics discussed in this 4th meeting of the NCC, including:

1. The AICPA has an exposure draft out for comment that is proposing to remove much of the state and local government content from the CPA exam.
2. The newly appointed GASB Chair is from the private sector, this is the first time in GASB's 35 years the Chair has not had a state or local government background.
3. The Governance Committee has been drafting a diversity and inclusion statement for consideration by the National Governing Board (NGB).
4. 2020-2021 NCC Representatives can self-nominate for consideration for one of the open NCC Director positions. The deadline is February 21.
5. There is a working group looking at criteria for closing and opening AGA chapters.

Certified Government Financial Manager (CGFM) is a professional certification awarded by AGA, demonstrating competency in governmental accounting, auditing, financial reporting, internal controls and budgeting at the federal, state and local levels.

CGFM is a respected credential that recognizes the specialized knowledge and experience needed to be an effective government financial manager.

Obtaining a CGFM allows you to expand your career opportunities and distinguishes you from others in your field.

How do you become a CGFM?

To earn the CGFM, you must complete an online application and meet the following requirements:

- Ethics – read and agree to abide by AGA’s Code of Ethics
- Education – have a bachelor’s degree in any subject area from an accredited U.S. college or university
- Examinations – pass three comprehensive CGFM examinations
- Experience – have at least two years of professional-level experience in government financial management

As topics are considered for the Historian's corner, I generally review past newsletters. However, since this is the time of year for the announcement of national awards, following are some of the awards the chapter has received in the past twenty years. Congratulations to a job well done.



- o **Chapter Recognition Awards for Points earned**– The chapter has received the Silver (over 10,000 points), Gold (over 17,000 points), or Platinum (over 19,500 points) award each year for at least the last twenty years.
- o **Citizen Centric Reporting (CCR)** – - This report helps simplify communication between governments and its citizens, who have a right to accurate information about the way their government spends their taxpayer dollars. AGA's concept of a CCR is a visually appealing four-page document that includes government entity mission, vision, and goals, plus community demographic information such as population and other interest items; performance information for key service areas, demonstrating progress (or not) over the prior year's efforts; detailed revenue and expense information highlighting changes from prior years and a look to the future and "what's next" in the year ahead, plus any foreseen challenges in meeting states goals. Chapters with well-designed and informative CCRS receive the AGA Certificate of Excellence, which the chapter has received numerous times since this program started.
- o **Chapter Education Award** – This award recognizes chapters that have done an outstanding job in providing educational programs to its members and other accountability professionals. The chapter won this award at least once for our size category.
- o **Chapter Newsletter Award** – Chapters submit one newsletter issue that best represents their work during the year. The publications are judged on usefulness of content and quality of design. The chapter has received the chapter newsletter award numerous times for our size category.
- o **Chapter Website Award** – Chapters submit their websites for consideration for this award. The websites are judged on quality of design, timeliness of content, and audience appeal. The chapter has received this award numerous times for our size category.
