

I'm proud to announce our speaker for this year's Spring Ethics Seminar. Dale Carnegie, author of such books as "How to Win Friends and Influence People" and "How to Stop Worrying and Start Living", was an influential writer and lecturer on self-improvement, public speaking and interpersonal relationships of the early twentieth century. One of his lasting legacies was the formation of Dale Carnegie Training, a program that continues to teach his principals to students world-wide. Join us May 14, 2015 at the Stoney Creek Inn Johnston as the local Dale Carnegie Training staff present a custom designed dynamic learning event demonstrating how these principals can be used to guide everyday ethical decision making.

AGA Chapter meeting minutes February 18, 2015


Gabe opened up the meeting with a welcome and announcement that the May Ethics conference early bird registration will be put on the website soon. The event will be Thursday May 14th. Dale Carnegie group will be doing the presentation. Their trainings are very interesting, innovative and active. Two of our CEC members drove out of state to a training a few years back and it was well worth it. The training will be at the Stoney Creek Inn again this year. Early bird fees are as follows: Members: \$90.00. Non-members are \$120.00. Fees go up \$10.00 for each after the close of early bird registration.

The topic of today's meeting was the AGA Citizen Centric Report. Gabe Stafford, Janice Jensen and Deb Schroeder all did a great job presenting the topic. Gabe led us through our own citizen centric report. The first page of the report shows our goals, vision & demographics. The second page lists performance measures. The third page has financial info and the fourth page includes planning for future, encouragement for people to take the CGFM exam, etc.

Jan has had the opportunity to be a Citizen Centric report reviewer and shared three reports with us: City of Tallahassee, National Science Foundation and the State of Texas. The reports are fairly similar to each other except the National Science Foundation is required by OMB to include annual reporting. Their report was 6 pages long, as compared to the typical 4 pages. The reports should be understandable to a non-accounting person.

Deb covered the AGA National power point on Citizen Centric reporting. It includes a good description of what should be in the report and how to construct one. Generally citizens tend to be dissatisfied with Government and want clear understandable information and transparency. Here is the link to the AGA national website <http://www.agacgfm.org/home.aspx>. Treasurer's report - Budget is on target and we'll be at break-even for the May ethics conference. There are two checks from last year's fund raisers that have not cleared the bank yet.

Audio conference refund procedures – Gabe suggested we look at this with a customer service perspective and decide whether to offer a refund on a case by case basis.

Vote whether to host Feb 11, 2014 and/or February 25th NASACT Webinars – Each one costs \$299.00 and we need to be able to break even. We decided to ask the auditors who would attend the Feb. 11th Green Book event and ask DAS employees who would attend the Risk Management event on February 25 before we vote.

May 2015 Ethics conference – May 14th, 2015 with the ethics audio the day before. Dale Carnegie is presenting at the conference. We need to get an agenda sent out once all the decisions have been made (and once we receive more info from Dale Carnegie.) Jan and Deb will pick out the food menu.

Registration prices are set:

Members: Early bird = \$90.00 or \$100.00 later

Non-members: Early bird = \$120.00 or \$130.00 later.

Early Bird Registration deadline will be April 15, 2015. The audio on May 13th will be included in the price of the conference for those individuals attending the all-day conference; regular price if not attending the all-day conference. We will have another CEC meeting in April to finalize details. Lilly will be gone the week of the conference so we need someone to cover the CPE credits. We should do a folder again this year and include other AGA stuff, i.e. pamphlets, etc. We can get freebies from Natl. and we may have gotten some stuff from the recent SLMR some of us attended. Val volunteered to help out if needed.

Membership Update - Maintaining members. 14 members and 3 non-members at the last lunch 'n learn and at the last webinar there were 9 members and 3 non-members. Tracy till let National know what we're going to do with the recruitment scholarship, which is due January 31st.

Scholarship money – We will use the \$151.00 scholarship to pay for pizza and cupcakes at the March chapter meeting where we always celebrate CGFM month. Any remaining balance will go towards the May 13 web conference expenses (free for members). Val made a motion to pass this. Denise seconded and all approved. Gabe asked about the Young Professional scholarship for people under 30 to attend the PDT (Professional Development Training) for free. Deb received a National PDT "registration" scholarship last year (for working at PDT). In past years, National has also provided two hotel scholarships for each local chapter's use.

CEC officers for next year – We need to start recruiting now.

Newsletter – Jyl will come back next year if no one else volunteers

Secretary – Val will not be filling this duty next year

Discussion ensued about contacting former CEC members to see if they are willing to come back.

Speakers for upcoming meetings –

March 18 – CGFM month. Not sure about speaker.

April and May Lunch 'n learns – Jeff Berger Deb will check with Jeff.
