Dear Members,

Thanksgiving has come and gone and I hope you were able to celebrate in a safe manner and enjoy the holiday. As we approach Christmas (the Season of Giving) and the New Year, we need to reflect on what is truly important. According to the U.S. Census Bureau, 12.7% of American households are experiencing food scarcity, which the [New York Times](#) defines as, "Households experiencing food scarcity are those in which there was either sometimes or often not enough to eat in the past seven days." Based on the U.S. Census, the total U.S. household estimate was [120,756,048](#) from 2015-2019. That means over 15 million households are food insecure, with the largest percentage of the household consisting of children. Similarly, though not exclusively, 9.1% of households are facing housing insecurity, which the [New York Times](#) defines as, "People experiencing housing insecurity are those who are behind on rent or mortgage payments, or who have slight or no confidence that their household can make next month's rent or mortgage payment on time." Applying the same metrics, nearly 11 million households are housing insecure.

Our chapter is active in serving the community, so this year we donated to Feeding Kentucky. We will be considering other non-profits that are dedicated to alleviating housing insecurity for our quarterly donation. If you have the means, please donate to [Feeding Kentucky](#) which helps one in seven Kentuckians gain access to food. Or, conversely, if you need help, do not hesitate to reach out to the many organizations available to you. When we support our community, we are better as a whole. As our Commonwealth's motto states, "United We Stand, Divided We Fall."



The Uniform Guidance and Compliance Supplement are important to understand in order for an organization to comply with the grant requirements including the Single Audit Act or grant specific audit requirements.

This session will cover the key aspects of the changes to the Uniform Guidance and the 2020 Compliance Supplement to better understand the impact on grants based on the results of Single Audit Act or program specific audits.
