**ACTIVE SHOOTER TRAINING**

**Presented by: Clark Marrow**  
**SB County Sheriff's Dept.**

Mr. Marrow is currently employed by the San Bernardino County Sheriff's Department to work with deputies in a program called Operation CleanSWEEP. He obtained his education from St Mary's College in Minnesota as well as Cal State San Bernardino.

Heavily involved in juvenile crime issues: he is a member of the International Association of School Safety Professionals, the Southern California Juvenile Officers Association, the San Bernardino County Drowning Prevention Network, the Inland Empire SAFEKIDS Coalition, the National Association of School Resource Officers, and the San Bernardino County-wide Gangs and Drugs Task Force.

The program he has worked on since 1997 – Operation CleanSWEEP – was the recipient of the 1997 National Association of Counties Achievement Award for Innovative County Government Programs, and the 1998 Juvenile Justice and Delinquency Prevention Commission Award for contributions to the youth of San Bernardino County. Clark wrote and won a two-year \$1.2 million grant for Operation CleanSWEEP. He was given the "You Make a Difference" Award from the San Bernardino County Office of Education in 2005 for his work on behalf of children. He has been named "Employee of the Year" in the Sheriff's Public Affairs Division on two occasions.




