Executive Proclamation
State of South Dakota
Office of the Governor

Whereas, The South Dakota Chapter of the Association of Government Accountants (AGA) is a professional organization and member of the AGA, which is a network of 13,945 members in 100 chapters in the United States and around the world dedicated to AGA; and,

Whereas, The South Dakota Chapter of the AGA has approximately 92 active members that represent state, federal, and municipal accountants, auditors, and financial managers; and,

Whereas, The members of the South Dakota Chapter of the AGA have responded to the AGA's mission of Advancing Government Accountability as it continues its broad educational efforts, with emphasis on high standards of conduct, honor, and character in its Code of Ethics, and through such efforts, significant advances are being made in professional ability and service to the citizens of South Dakota by mastering increasingly technical and complex requirements; and,

Whereas, The Certified Government Financial Manager (CGFM) program of the AGA provides a means to demonstrate professionalism and competency by requiring CGFM candidates to have appropriate educational and employment history, to abide by the AGA's Code of Ethics, and to pass examinations requiring expertise in Governmental Environment, Financial Management and Control, and Accounting, Financial Reporting, and Budgeting, and requires each CGFM designee to maintain their professional competence by completing at least 80 hours of continuing professional education every two years; and,

Whereas, The number of those achieving the CGFM designation has risen to 12 in the state of South Dakota, a recognition of the talent and dedication of those dedicated to the service of the citizens of the state;

Now, Therefore, I, Dennis Daugaard, Governor of the state of South Dakota, do hereby proclaim March 26-31, 2017, as
