- Δ Discussed minutes for October, November, and December. Nicole will review and note any needed changes.
- Δ Discussed our upcoming events. The February Ethics Training has D Scot Loyd presenting on Ethics. Walt has emailed the Board of Accountancy regarding the use of the CPE by Accountants. Susan, of the Board of Accountancy has approved the use of these CPE for CPAs. The March event has Katrin Osterhaus of LPO providing an overview of the IT audits conducted over the past 3 years by Post Audit. No event has yet been organized for April or May.
- Δ Walt noted that the December newsletter was completed and published on the website and distributed via email to the membership.

State Agencies and Internet Security

A Report on Three Years of Agency Audits



This presentation was held in the Florentine Room of the Jayhawk Building on March 9, 2017. Our speaker, Katrin Osterhaus, provided us an overview of the process used by auditors and the results of the audits.

The primary purpose of the audits was to determine the ability of State agencies to avoid the embarrassment of many private companies that have been “hacked” giving up customer information such as social security numbers, birth dates, email addresses, home addresses and much more.

Over the course of three years, the auditors asked routine questions, visited agency information technology centers, performed basic security analyses, and did some quiet security checks. These checks included sending fake email to employees to see if the employees would violate protocols if presented with an email that looked realistic.

The findings included simple measures like locks on doors, identity checks of individuals trying to enter computer centers, and providing of information without obtaining identification of the requesting party. The most serious problem appeared to be the lack of change after repeatedly notifying the agencies of serious breaches of security. The Legislature is responding to the information found by the audits.

WHEREAS, The Certified Government Financial Manager (CGFM) program of AGA provides a means of demonstrating professionalism and competency by requiring CGFM candidates to have appropriate educational and employment history and to pass three examinations requiring expertise in The Government Environment, Governmental Financial Management and Control, and Governmental Accounting, Financial Reporting and Budgeting, and, requires each CGFM holder to maintain certification by completing 80 hours of continuing professional education in government financial management topics or related technical subject every two years;

NOW, THEREFORE, I, Sam Brownback, GOVERNOR OF THE STATE OF KANSAS, do hereby proclaim March 2017, as

Certified Government Financial Manager Month

in Kansas and urge all citizens to join in this observance.
