- Discussed the National PDT conference to be held in Dallas, TX in July. We receive 2 hotel scholarships as a chapter. Several folks inquired and expressed interest in attending. We will monitor the COVID situation and discourage purchasing plane tickets for a few weeks until it becomes clearer on whether the conference will be held as scheduled. We will circulate an email to CEC members to gauge interest in attending the national PDT and will consider offering a subsidy from the Chapter for interested individuals to attend so that more than 2 may attend (since we did not have a PDT this year)
