Chapter Year 2018-2019 Was Again a Very Successful Year for the Chicago Chapter

Thank you to our members and the Chapter Executive Committee for another great Chapter year!

Our Chapter provided 36.5 hours of continuing professional education. All of the educational events were highly rated based on the feedback and evaluations we received. The Chapter's Professional Development Training program in May 15-16, 2019 was the highlight of the year attracting three great speakers and about 80 attendees. We awarded 12.3 CPEs for this event. The Chapter collaborated with the local chapter of the Institute of Internal Auditors to put on the "Fall into Training" event on August 20, 2018. We awarded 6.5 hours of NASBA CPEs for 84 attendees to this training event. The Chapter maintained its accreditation as a CPE sponsor by the National Association of State Boards of Accountancy. We also gave back to the community through several events such as: book drives, veterans walk, making donations to veteran's organizations and to student organizations; and also participating in the VITA tax preparation assistance program. Our members attended AGA's National Professional Development Training and the Sectional Leadership Meeting.

In addition, the Chapter staffed an exhibition table at the Institute of Internal Auditors Chicago Chapter's 59th Annual Seminar in Rosemont, IL. The Chicago Chapter's efforts culminated with achieving Platinum Status in AGA's Chapter Recognition Program.

- The Chicago Chapter was awarded Platinum status in AGA's Chapter Recognition Program. Platinum is the highest level a chapter can obtain.
- Offered educational events that provided 36.5 hours of continuing professional education.
- Partnered with the local chapters of the Institute of Internal Auditors and the Association of Certified Fraud Examiners to provide continuing professional education training.
- Maintained accreditation as a CPE sponsor from the National Association of State Boards of Accountancy.
- Sent two Chapter Executive Committee members to the Sectional Leadership Meeting in Baltimore, MD.
- Sponsored three Chapter members who attended the 2019 National PDT in New Orleans, LA.
- Provided study guides to members interested in pursuing the CGFM certification.
- Made four donations for scholarships to be awarded to local college students.
- Was awarded AGA's Certificate of Excellence in Citizen-Centric Reporting for our 2018 Chapter CCR.
- Participated in various community service activities including the VITA tax preparation assistance program, a book drive, and the Chicago Veterans Ruck March.
