Community Service Events:

- Donation of Iowa products to National PDC Community Service Raffle in July 2016 in Anaheim, CA.
- August – September, 2016 – Collected donations of cash for Paws & Effect, which raises, trains, and places service dogs with children and veterans with disabilities. Total contributions, including Des Moines AGA and national AGA matches totaled \$320.
- October – November 2016 – Collected donations of cash and food and household items for the Food Bank of Iowa. Their mission is to alleviate hunger through food distribution, partnership and education. Total contributions, including Des Moines AGA and national AGA matches totaled \$663 plus 82 pounds of non-perishable items.
- December 2016 – January 2017 - Collected cash donations for the Lupus Foundation of America.
