




AGA Central Kentucky Chapter Citizen-Centric Report 2021-2022

About the Central Kentucky Chapter

In June 2021, The AGA Central Kentucky Chapter (Chapter) celebrated its 43rd anniversary. Our mission is to serve professionals in the governmental finance community by providing quality continuing education, fostering professional development and certification, and supporting standards and research to advance governmental accountability. To accomplish our mission this year, the Central Kentucky Chapter provided educational opportunities to our members and other professionals in the accountability community through monthly chapter meetings, one fall training session, and one spring training session.

In addition, the Chapter works to help members prepare to take the Certified Government Financial Manager (CGFM) exam by providing a facilitator and study materials. As most members work in state and local government, our Chapter seeks to provide affordable programs to meet their specific needs. Chapter leadership actively requests input from members and other governmental financial managers regarding their educational needs.

AGA Central Kentucky Chapter Objective:

The AGA Central Kentucky Chapter serves the Commonwealth's government accountability professionals by providing quality education, promoting professional development, and promoting professional certification.

Chapter Operations & Membership Development

The Central Kentucky Chapter is one of 96 AGA chapters across the United States and world-wide. A Chapter Executive Committee (CEC) composed of five Officers and nine Directors governs the Chapter. The CEC meets monthly to conduct Chapter business and plan educational events.

In fiscal year 2022, we saw 24 new members join our Chapter. The Chapter membership of 165 members include governmental professionals from all levels of local, state, and federal government. Other members work in non-profit organizations, private entities, and academia.

About 68% of our members are employed by state government, 10% by the private sector, and 9% by city, county, and federal governments. Our remaining membership is comprised of individuals from non-profits and academic institutions as well as retirees.

Numerous private sector employers have contracts to perform accounting, auditing, or consulting work for various government entities. These organizations encourage employees to join AGA to ensure they become knowledgeable about governmental accounting and its changing environment while maintaining professional credentials.

The Chapter and its members gained national recognition receiving the Platinum Chapter Recognition award for meeting their annual credit goal for 2020-2021. Recent achievements include: 2018-Platinum; 2019-Platinum; 2020-Platinum; and 2021-Platinum.

Education and Programs:

We awarded 31.0 total hours of continuing professional education (CPE) to 932 members and guests during fiscal year 2022. Opportunities to attain CPEs included virtual monthly chapter meetings for 1.0 hour of CPE each, and two Professional Development Trainings for 7.0 hours for the Fall training and 14.0 hours of CPE for the Spring training.

Finances


During fiscal year 2022, the Chapter’s financial position remained strong. Cash reserves were \$26,535 in May 2022, a decrease of \$5,327 from May 31, 2021. Our revenues are derived from meeting-related training events and \$5 annual chapter dues. The CEC sets monthly meeting fees for AGA members under cost to encourage attendance.

Meeting expenses include costs for virtual speaker fees, charitable donations to thank speakers and an additional ad hoc donation to assist our community in the Western KY Tornado Relief Fund. Other costs include post office box rental, website fee, and scholarships for young professionals.

Each month, the CEC reviews the financial statements, which are then published in the Chapter newsletter.

To ensure accountability of Chapter funds, representatives from the Kentucky Public Pensions Authority performed an audit of our Chapter.

Community Service:

Our chapter is active in servicing the community. The Chapter's strong financial position enabled us to donate \$1,200.00 to a variety of charities for local projects including the following: Franklin Co Humane Society, Feeding Kentucky, and the Western Kentucky Tornado Relief Fund. The Chapter donates to a charity of each speaker's choice to help enhance the community service efforts, which totaled \$576.75. Speaker donations included the following: National AGA, Frankfort Independent Schools, Franklin Co Humane Society, Monroe Carrell Jr. Children's Hospital at Vanderbilt, Jessamine Co Humane Society, Jessamine Humane Animal Care & Control, Tyson's Chance Animal Foundation, Teen Challenge Kentucky, Western Kentucky Tornado Relief Fund, St. Jude, Kentucky Humane Society, Mission Frankfort Clinic, Grace Fellowship of Lexington, Alzheimer's Association, My Dog Eats First, Equal Justice Initiative, and VIPS – Visually Impaired Preschool Services.

Certified Government Financial Manager

AGA offers a certification tailored to the governmental environment: Certified Government Financial Manager. Attaining CGFM status requires experience in government financial management, a suitable educational background, and a passing score on the exams, which cover the governmental environment, reporting and budgeting, and governmental financial management and control. By spanning local, state, and federal operations, CGFM holders are equipped to perform and lead at any level of government.

The Central Kentucky Chapter supports members seeking to earn CGFM certification. The Chapter has an active study group that helps participants prepare for exams and encourages them to stay on course. The chapter owns and provides current study guides to participants to assist their efforts. We also support the CGFM program by providing notice of training relevant to the CGFM examination content.

CGFM Requirements:

- Read and agree to abide by the AGA's Code of Ethics
- Have a bachelor's degree from an accredited college or university
- Pass three comprehensive CGFM Examinations
- Have at least two years of professional-level experience in government financial management

Challenges

COVID-19 has created many challenges and significantly altered traditional methods of transacting business for most businesses across many sectors. Additionally, the pandemic has prompted unforeseen opportunities to rethink processes and foster innovations that will likely continue when the crisis is over.

An ongoing challenge the Central Kentucky Chapter has faced is how to attract young professionals to the AGA. We have focused efforts on helping new members become involved with the Central Kentucky Chapter. The Chapter awarded one \$1,500 undergraduate scholarship and one \$1,500 graduate scholarship as part of the outreach program where qualified candidates must be in good standing with a major in accounting.

The Chapter also continuously encourages its members to pursue obtaining the Certified Government Financial Manager certification.
