


ABOUT US



CHAPTER FINANCIALS


During the 2023 - 2024 Program Year, the D.C. Chapter expanded our membership activities, leading to increased costs in several areas. For VIP Luncheons, costs rose due to a higher number of sponsors, a venue change to meet accessibility standards, and increased food and beverage minimums. The Awards Gala cost increased due to a larger venue needed for higher attendance, which grew from 60 to 110, and more complimentary registrants, including award winners and sponsors. Monthly Luncheon Costs also increased as we boosted in-person attendance from an average of 57 to 88, subsidizing a portion of the lunch costs. These changes were made to enhance member experiences and demonstrate value to our sponsors.
