Our sworn employees, the frontline heroes, tirelessly work to prevent and investigate crimes, safeguard highways, and respond to emergencies. Simultaneously, our Professional Staff play a pivotal role in supporting sworn employees, law enforcement partners, and the public by adeptly handling technical, scientific, and logistical tasks.

The ISP Headquarters is in Meridian, Idaho, where we serve a population of over 1.9 million through six regional districts:

**District 2, Lewiston:** Clearwater, Idaho, Latah, Lewis, and Nez Perce Counties.

**District 3, Meridian:** Ada, Adams, Boise, Canyon, Elmore, Gem, Owyhee, Payette, Valley, and Washington Counties.

**District 4, Jerome:** Blaine, Camas, Cassia, Gooding, Jerome, Lincoln, Minidoka, and Twin Falls Counties.

**District 5: Pocatello:** Bannock, Bear Lake, Bingham, Caribou, Franklin, Oneida, and Power Counties.




#### STRATEGIC GOALS

## **REVENUE & EXPENDITURES**

Idaho State Police receives most revenue from dedicated sources, including state and federal funds. Usually, revenue collection is built into user fees or taxes that finance a specific service or project - for example, vehicle registration fees or fuel tax funds.

General funds are collected from taxes and fees imposed by the state, such as individual income and corporate tax, whereas federal funds include allocations for specific programs. Federal funds are often passed through other state and local governments for criminal justice activities.

#### TO GOVERNOR LITTLE AND THE CITIZENS OF IDAHO.

2023 marked a significant milestone for ISP, with increased support from the Governor's Office and the Idaho Legislature. This support enables us to enhance our training programs, address salary concerns, mitigate fuel costs, acquire essential safety equipment, and most importantly, add new positions for trained staff. These positions include a centralized Records Manager for more efficient records processing, two Commercial Vehicle Safety Specialists to meet the growing demands of the motor carrier industry, seven Forensic Investigators for cold cases and DNA collection, two Technical Records Specialists (TRS) in the Sex Offender Registry Unit, and additional hours for evidence processing. Additionally, we welcomed one SART/SANE nurse, crucial for essential training and supporting law enforcement in sexual assault and forensic cases, and seven additional troopers for the Domestic Highway Enforcement (DHE) Team. The DHE expansion will work with our K-9 units to combat illegal drugs and enhance highway safety. Recognizing the threat posed by illegal drugs, particularly fentanyl, to communities across our state, DHE remains a priority within the Esto Perpetua initiative.

As we continue to progress, ISP remains steadfast in our commitment to upholding the highest standards of professionalism, integrity, and service. Our vision fosters an environment of accountability and transparency across all our operations, and we are dedicated to safeguarding constitutional rights, protecting property, and enhancing the overall quality of life in our magnificent state. Collaboration and building robust partnerships with local law enforcement agencies, government entities, community organizations, and the public remain at the core of our strategy to ensure the security of Idaho.

We are sincerely grateful for your trust and support in ISP as we continue serving Idaho. We remain resolute in dedication to our mission.
