## Who Are We?

As the fourth largest town in Virginia, Christiansburg serves as a destination for retail, dining, recreation and community events. Settled within stately views of the Blue Ridge Mountains, the Town is located minutes from Virginia Tech, Radford University and two major hospitals. Christiansburg is conveniently located at the crossroads of three major highways: I-81, US Route 11 and US Route 460. VA Routes 8 and 114 also provide connectivity to the Town. Proximity cultivates an environment of diverse opportunities both within the Town and regionally.

The Town of Christiansburg operates under a Council-Manager form of government. The Town Council is the legislative body of the Town, comprised of the Mayor and six council members who enact laws, determine policies and adopt the annual budget. Every year, the Town Council appoints the Town Manager, Chief of Police, Treasurer, Clerk of Council and the Town Attorney. ## Active Destination

Recreation and Aquatics programs provide a space for residents to improve their quality of life by exercising and socializing with others. As the retail hub of the New River Valley, Christiansburg continues to be a regional resource for shopping and recreation opportunities. With quality facilities like the Aquatic Center and new

facilities like Christiansburg Huckleberry Park, (the new approx. 50-acre park expected to be completed early 2023) Christiansburg anticipates an influx in visitors, benefiting local businesses through tourism.

## Clean, Green, Healthy & Safe

In 2022, Town Council created the Sustainability Committee in an effort to further discuss the Town's environmental concerns and better communicate ways the Town has worked toward a more clean, green and healthy community. The committee ran its inaugural campaign in the fall of 2022 which included information on recycling, solid waste, and seasonal cleanups. 


## Fiscal Year 2021-2022 - Percent of Actual Revenues

## Financial Structure The Town manages revenues and expenditures through various funds.

**Capital Projects Fund** - grants and local, state and federal funds as well as unassigned reserves • **Cemetery Fund** - permanent fund from plot sales and funeral services • **Enterprise Fund** - water and sewer services, and stormwater fees • **General Fund** - property taxes, meals and lodging taxes, business licenses and solid waste collections • **Special Revenue Fund** - federal and state grants, as well as other sources, that have restrictive use



Post-pandemic, the Town of Christiansburg continues to make economic gains. Two of the Town's largest revenues, meals and lodging taxes, exceeded pre-pandemic levels in 2022, helped along in part by the new Marketplace Shopping Center, which added 6 new restaurants. The Town continues construction of Christiansburg Huckleberry Park which should be completed in Spring of 2023. It is anticipated that the Town will see an increase in tourism once the Park construction is completed and the Park's amenities are open to the public, which should positively affect meals and lodging taxes in the upcoming years. While the Town continues to budget revenues conservatively, we are optimistic about the Town's economic future and the ability of the Town to be able to continue to fund improvements to infrastructure.

## Projects Substantially Completed in 2022



### Tower Road Improvements FY 2021-2022

Crews installed a traffic light at the intersection of Tower Rd. and Hampton Blvd. This project also included pedestrian signaling as well as sidewalks.



### Arbor Drive Intersection Improvements FY 2021-2022

This project included the construction of a left-turn lane from Arbor Drive, curb and gutter, a sidewalk, accessible ramps, crosswalks, median modifications and a signal head addition.

## Projects in Progress for 2023



### Christiansburg Huckleberry Park Duration: Spring 2021 to Spring 2023

An approx. 50-acre park off Peppers Ferry Road with four full-sized rectangular fields, two picnic pavilions, a splash pad, a small and large dog park, an inclusive playground, an adult fitness zone, a challenge course, nearly two miles of trails, and green space for passive recreation.



### Waterline Replacement Duration: Spring 2021 to Spring 2023

This project will take place on Roanoke St. extending From E. Main St. to Depot St. The existing 8" aged, waterline will be replaced with a new, 12" waterline. This project will also include the replacement of service lines and meters.
