The Treasurer provides independence from the Board of County Commissioners (the legislative branch) as well as all other various local governments that have the ability to levy taxes and assessments. This provides separation from the branch levying taxes and the branch collecting tax revenues.

## How are we set up?

The County Treasurer's office is charged with the collection of various taxes along with acting as the "bank" for the county, school districts, fire districts, water districts, and other entities of local government. Tax adjustments authorized by the Assessor's office or courts are also processed and refunds are issued to the appropriate taxpayers. Excess monies not currently being used by the county or various local governments are "pooled" for investment with the emphasis of ensuring public monies are safe and secure, available when needed, and achieve the best rate of return after meeting the first two objectives.

### Upcoming Year Goals

The Treasurer's Office acts as the Program Administrator for the County's Procurement Card (P-Card) Program, a corporate credit card solution used to streamline purchasing. We will review P-Card platforms to verify we have access to more stringent safeguards and additional oversight.



As the Treasurer for Benton County and the Districts we serve, communication is very important. Our team will be working on revamping our website to ensure we have relevant, up-to-date information for taxpayers and districts. This will include updating the content, refreshing layouts and making it more user friendly.

Accuracy and safeguarding of public funds is of the utmost importance to our office. This year, we will be reviewing and updating our Cash Handling Policy and Procedure. With changes in technology and banking processes, it is important to review periodically to enhance security, mitigate fraud and ensure accurate financial reporting.

### Financial Software Conversion

Benton County underwent a financial software conversion in 2022. This year, our office, along with other departments, worked diligently to establish and implement new procedures to ensure accurate reporting and safeguarding of public funds.

### Investments

The Treasurer's office strives for transparency and open communication. As a result, we met with our Investment Pool participants to better understand their financial needs to enhance our investment plan to allow us to maximize return while meeting our cash flow.

### Vendor Contracts

Our office continually looks for solutions to offer our taxpayers and districts we serve. We look for options that provide high safeguards, while being convenient and economical. Through our search this past year, we found that many of our vendors are competitive in their respective industries and found some new options to maximize security, like with our Purchasing Credit Cards.

### Where Did Your Tax Money Go?

Property assessed values and levy rates are certified annually, with the Assessor's office, and used to calculate the property taxes for each taxable real and personal property parcel. The Treasurer then issues statements informing taxpayers of the amount to be collected for the year. Property taxes are collected by the Treasurer's Office and distributed to their respective county/district funds as levied by each taxing district. Below you will find the distribution of property taxes for 2022 and 2023.

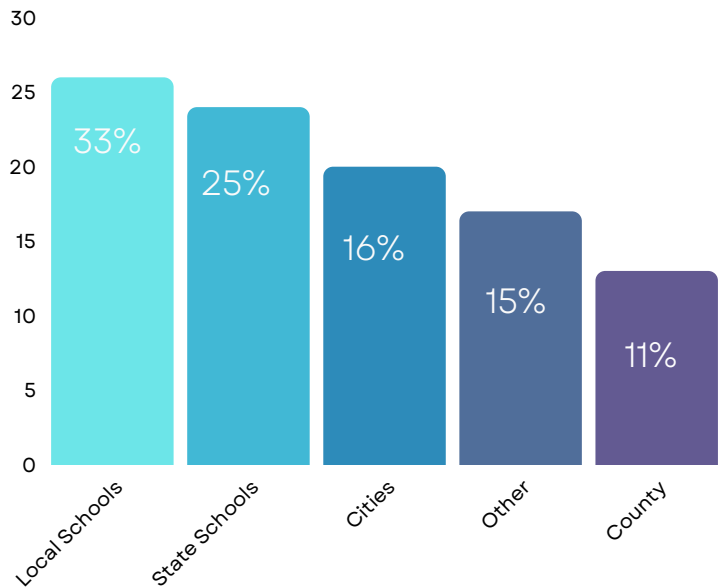

\* State School is a levy all property taxpayers pay for public schools and Local School is tax levy approved by voters for a specified school district.

### How Your Tax Dollars are Distributed

Tax monies are billed and collected on an annual calendar basis. The funds collected are vital to functions within the County and used to provide public services for the taxpayers (i.e. schools, fire and EMT services, roads, etc.). The graph below displays the percentage of total property taxes distributed to each taxing district category for the 2023 tax collection year.

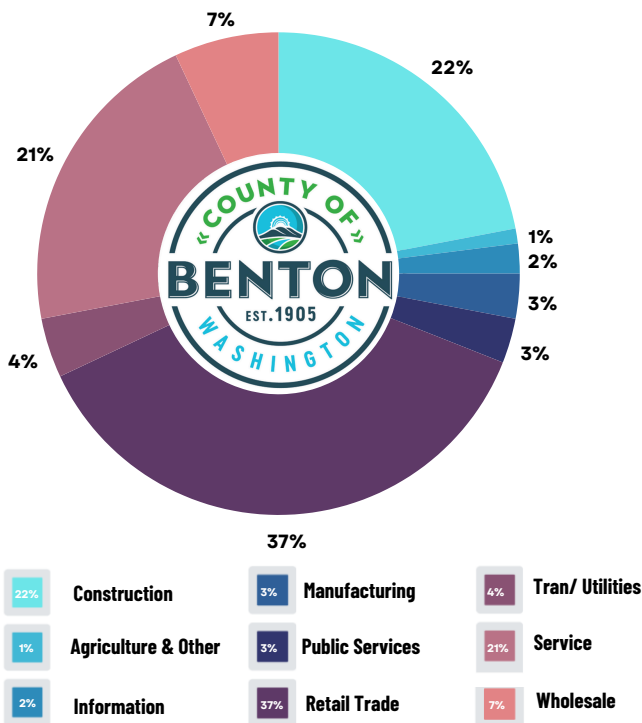

### Sales Tax Distrubution

The Treasurer's Office monitors and analyzes local retail sales & use tax trends. Our office receives data from the Department of Revenue on a monthly basis. Analyzing data helps our office be more accurate when forecasting future revenue.

The Pie chart below displays the breakdown of the collected sales and use tax for the 2023 tax year. The total collected for 2023 was \$16,808,790, a small increase from 2022.\*



\*Total tax reflects current expense receipted into the general fund, less refueling tax received. (Refueling tax is only received on odd number years.)

### County Demographics

Inflation has continued to be on the rise, which has been a contributing factor to the increase in unemployment rate, as well as the decrease of new construction experienced this year. We are optimistic to see an increase in building permits which will soon turn into new constructions, adding more value to our County and increasing our tax base. An increase in tax levied will provide more services for the county such as school funding, road work, capital projects and more.
